

Towngas China receives Five-Star Chinese Corporate Citizen 2019 award for green development empowering the future

(12 November 2019) The Corporate Citizenship Committee of China Association of Social Workers hosted the 15th Chinese Corporate Citizen Exchange Summary Meeting in Beijing.
